The above warranty shall not apply to any Product which, at our sole judgement, has been: i) repaired or altered by persons unauthorized by us; ii) connected, installed, adjusted or used otherwise than in accordance with the instructions furnished by us (including being used in an inappropriate installation environment, such as in corrosive gas, high temperature and humidity). We warrant the specification, unless otherwise specified, at max. rated output after warm up, and scope of application is between 10% and 100% of max. rated output.

We assume no liability to the purchaser or any third party for special, incidental, consequential, or other damages resulting from a breach of the foregoing warranty. This warranty excludes any and all other warranties not set forth herein, express or implied, including but not limited to, the implied warranties of merchantability or fitness for a particular purpose. We are not liable for any loss, damage or failure of the Products after the shipment thereof caused by external factors such as disasters.

We will not inspect, adjust or repair any of the Products in the field or site of the customer.
