#### REGISTRATIONS

#### A. DOE Office of Science Portfolio Analysis and Management System (PAMS)

The Department of Energy (DOE) Office of Science (SC) performs many functions for DOE national laboratory proposals in the Portfolio Analysis and Management System (PAMS), which is available at https://pamspublic.science.energy.gov.

You must register in PAMS to submit a pre-proposal, letter of intent, or DOE national laboratory proposal.

To access PAMS, you may use the Internet Explorer, Firefox, Google Chrome, or Safari browsers.

Notifications sent from the PAMS system will come from the PAMS email address < <u>PAMS.Autoreply@science.doe.gov</u>>. Please make sure your email server/software allows delivery of emails from the PAMS email address to yours.

Registering to PAMS is a two-step process; once you create an individual account, you must associate yourself with ("register to") your institution. Detailed steps are listed below.

#### 1. CREATE PAMS ACCOUNT:

To register, click the "Create New PAMS Account" link on the website <a href="https://pamspublic.science.energy.gov/">https://pamspublic.science.energy.gov/</a>.

- Click the "No, I have never had an account" link and then the "Create Account" button.
- You will be prompted to enter your name and email address, create a username and password, and select a security question and answer. Once you have done this, click the "Save and Continue" button.
- On the next page, enter the required information (at least one phone number and your mailing address) and any optional information you wish to provide (e.g., FAX number, website, mailstop code, additional email addresses or phone numbers, Division/Department). Click the "Create Account" button.
- Read the user agreement and click the "Accept" button to indicate that you understand your responsibilities and agree to comply with the rules of behavior for PAMS.
- PAMS will take you the "Having Trouble Logging In?" page. (Note: If you reviewed for or were listed as PI on a prior submission to SC but have not previously created an account, you may already be linked to an institution in PAMS. If this is the case, PAMS will take you to the PAMS home page.)

#### 2. REGISTER TO YOUR INSTITUTION:

• Click the link labeled "Option 2: I know my institution and I am here to register to the institution." (Note: If you previously created a PAMS account but did not register to an

- institution at that time, you must click the Institutions tab and click the "Register to Institution" link.)
- PAMS will take you to the "Register to Institution" page.
- Type a word or phrase from your institution name in the field labeled, "Institution Name like," choose the radio button next to the item that best describes your role in the system, and click the "Search" button. A "like" search in PAMS returns results that contain the word or phrase you enter; you need not enter the exact name of the institution, but you should enter a word or phrase contained within the institution name. (Hint: If your institution has an acronym, such as ANL for Argonne National Laboratory or UCLA for the Regents of the University of California, Los Angeles, you may search for the acronym under "Institution Name like." #### **SUMMARY**

The DOE SC program in Nuclear Physics (NP) hereby announces its interest in receiving interdisciplinary proposals for open scientific research on Quantum Computing (QC) and Quantum Information Science and Technology (QIST) with a clear line of sight to enable discoveries to explore and understand all forms of nuclear matter, including some that no longer exist. From the hot dense soup of quarks and gluons in the first microseconds after the Big Bang, through the formation of protons and neutrons beginning the evolution of the chemical elements, to the awesome power of supernovae, the physics of nuclei is fundamental to our understanding of the universe [1] [2].

Quantum Horizons: QIS Research and Innovation for Nuclear Science is a new initiative to identify, prioritize, and coordinate emerging opportunities in both fundamental research and applied challenges at the interface of Nuclear Physics and QIST. NP's Quantum Horizon's program emphasizes the science-first approach and is informed by the results of NP community research workshops "Opportunities for Nuclear Physics & Quantum Information Science" [3] and "Quantum Computing for Theoretical Nuclear Physics" [4] and the "National Strategic Overview for Quantum Information Science" [5], the Interagency Working Group on Quantum Information Science [6] and the Exploration of the Quantum Landscape meetings of the Nuclear Science Advisory Committee [7].

Responsive proposals will propose research that could, in the long-term, have a transformative impact on the NP mission area and/or advance QIS development enabled by NP-supported science, technologies, and laboratory infrastructure. Likewise, QIS technologies offer the ability to discover and probe the fundamental structure and behavior of Nature with unprecedented sensitivity and accuracy. While recognizing the interdisciplinary and crosscutting nature of QIS, responsive proposals should focus on areas consistent with the unique role and relevance of NP in this rapidly developing field.

Topics may include quantum computation, quantum simulations and simulators, quantum sensing, nuclear physics detectors, nuclear many-body problem, 'squeezed' quantum states, entanglement at collider energies, and lattice gauge theories as well as novel areas of basic research [3] [4] [8]. More specific information about responsive areas is included in the supplementary information section below.

The Quantum Horizons initiative encourages the exploitation of the interdisciplinary nature of Quantum Computing and Quantum Information Science and Technology to expand the frontiers of the NP program and the national QIS enterprise through partnerships with Universities, National Laboratories and Industry.

Proposals must follow the guidelines and criteria provided in the supplementary information P and the accompanying sections. Attention is called to the limitations on the number of proposals that may be submitted on behalf of a PI in Section III, Part D.

#### SUPPLEMENTARY INFORMATION

#### **Program Objectives:**

The NP mission is to discover, explore, and understand all forms of nuclear matter. NP supports experimental, theoretical and computational research - along with the development and operation of particle accelerators and advanced technologies - to create, detect, and describe the different forms and complexities of nuclear matter that can exist in the universe, Nuclear physics is a broad and vibrant subject spanned a wide range of interests centered on five science thrusts guided by the 2015 Long Range Plan: Reaching for the Horizons report that presents a strategy for nuclear science research for the next decade [1].

Among the approaches that NP relies upon to maximize the public benefit of research within DOE's Congressionally-authorized mission-space is to identify the most promising emerging advances in science and technology that can have a transformative impact and accelerate progress toward its goals and objectives.

QIS is a rapidly developing interdisciplinary field and has been identified as an important crosscutting topic with potential impact across all SC program offices [9] and where continued leadership is critically important to our nation's national security and economic competitiveness [5]. Emerging priority areas in QIS provide new opportunities to address challenges of enormous interest and complexity in NP.

NP has co-sponsored community workshops in the areas of intersection between nuclear physics, QIS, quantum computing, and QIS technology [3] [4]. These workshops explored the role of NP in QIS and QIS applications that could accelerate NP discovery science and expand the traditional frontiers of NP through QIS-enabled experiments, QC-enabled solutions to complex field theories and nuclear many body problems.

Informed by the findings of these workshops, NP is seeking proposals for its Quantum Horizons Announcement responsive to one or two of the research opportunities outlined in the NPQI report: "Opportunities for Nuclear Physics & Quantum Information Science" [3]:

**Research Opportunity I**: NP science and technologies for advancement of QIS call for collaborative projects between the NP and QIS communities that best leverage the respective strengths of universities, national laboratories, and industry. The field of QIS is highly competitive with many well-established research groups. Therefore, NP will

invest strategically so that it can most effectively contribute to and benefit from QIS. Some relevant NP strengths include: superconducting technologies, microfabrication, supercomputing expertise as well as pushing engineering to a level that is beyond what is commonly done in universities and industry. Collaborations within national laboratories is also encouraged, since the interdisciplinary nature of these institutions has a lot to offer QIS, which itself is highly interdisciplinary. For example, an analog quantum simulator built to study NP problems rooted in gauge theories using NP expertise in atom trapping or the technical development of QIS technologies such as "nuclear qubits" are within the scope of this research opportunity.

**Research Opportunity II**: Broad theory projects which can, e.g., develop methods and quantum algorithms that solve important problems in NP using emerging digital quantum computers, hybrid computers, quantum annealers and quantum simulators, utilize QIS concepts to better understand nuclear phenomena (such as the nuclear many-body problem and hadronization), and develop new QIS applications of importance to nuclear physics such as data analyses and machine learning. Significant advances in both NP and QIS theory (e.g. quantum algorithms) are still needed, which will require the dedicated effort of theorists from both communities.

Research Opportunity III: Research projects that seeks to develop or capitalize on QIS technology with applications for nuclear physics. Development of technology originally intended for QIS has frequently generated detectors that can be used to advance basic research. Support for research intended to implement quantum sensors for nuclear physics applications would further the interests of both the NP and QIS communities, while helping to generate crucial collaborations. Quantum sensors should exploit distinct quantum phenomena - superposition, entanglement, and squeezing - that do not have classical counterparts, to acquire, process, and transmit information in ways that greatly exceed existing capabilities. QIS technologies are quantum-essential supporting technologies that are not intrinsically quantum in themselves, but enable unprecedented precision and sensitivity measurements, for example by exquisite control of quantum systems such as individual atoms, molecules, and NV centers. Searches for electric dipole moments (EDMs) are perhaps the cleanest examples of a quantum sensor applied to NP fundamental symmetries research.

Research Opportunity IV: Creating a quantum-smart workforce for tomorrow. Proposals to develop a QIS workforce in the context of NP will be considered specifically for funding graduate students and postdocs who conduct research at the intersection of these QIS and NP fields. Proposals are encouraged between academia and industry on core research programs of mutual scientific benefit. NP problems that seem intractable today can potentially be addressed by a new NP workforce skilled in quantum computing and other aspects of QIS-inspired technology. Funding graduate students and post docs will be a priority, where collaboration with the DOE Office of Advanced Scientific Computing Research (ASCR) is proposed, as well as industry internships to leverage and facilitate ongoing intellectual progress on QIS/QC in the commercial sector.

Research Opportunity V: Ramping-up engagement. Proposals for conference meetings such as workshops, schools, and seminars could be supported so that the NP and QIS communities can better understand the challenges and capabilities of their counterparts. The full extent of cross-pollination between NP and QIS is not yet fully understood. A combination of workshops, pedagogical schools, and high-level seminars all of which could be broadcast online would promote technical exchanges, formation of new relationships and deepen engagement with researchers in the NP, QIS and Quantum industry. This Research Opportunity could provide a variety of other resources as needed to engage NP-supported individuals with external collaborators in order advance NP relevant quantum science and technology.

#### **NP-QIS Objectives**

The NP QIS Thrust is intended to forge new routes to scientific discovery along the NP mission [1] and Long Range Plan science drivers [2], invoking interdisciplinary advances in the convergent field of QIS, and their intersection with expertise, techniques, and technology developed within the NP community. The goals of the NP QIS Thrust include building interdisciplinary consortia and researchers that positively impact both NP and QIS fields.

A near-term objective for this NP "Quantum Horizons" initiative is to address the diversity of opportunities which could feature several new topics (i.e., key challenges) per year, with more than one team awarded per topic. The longer-term objective is to address "grand challenges" in NP that may require both support for more than one 5-year cycle as well as larger, multidisciplinary teams. Example challenges could include developing, implementing, and operating a large-scale network of quantum sensors for probing physics beyond the Standard Model or realizing a prototype quantum analog simulator with transformative capability.

NP recognizes that there is complementary and synergistic research supported by other SC programs and other agencies, and that coordination across such inter-office and inter-agency efforts will strengthen QIS at the national and international level. Proposals proposing new coordinated/collaborative activities with non-NP efforts are allowed, provided they justify clear delineations of the scope of the work proposed on the Quantum Horizons Announcement.

#### **Research proposals responsive to this Announcement:**

- Proposals from a single PI or multi-institutional with a lead PI.
- Should focus on one or two of the research opportunities I-V outlined above and have clear milestones and deliverables.
- All proposals must demonstrate relevance for the NP-QIS Objectives outlined above.
- All proposals that address Research Opportunities I-III must have investigators from NP and QIS disciplines and clearly explain how their proposed work will impact the NP research community and QIS.
- All proposals for funding must demonstrate their public benefit through increasing knowledge and understanding.

Please note that this Announcement is only for opportunities within the QIS Thrust in NP and is distinct from NP's routinely issued Announcement for Research and Development in NP.

The following topics and subjects are outside the scope of this Announcement. Applications dedicated to these items may be declined without merit review:

- General quantum computing algorithms.
- Purchase or development of Quantum Communication Networks or Quantum Computing systems.
- Quantum Security methods of communication and cryptography.
- Requests for basic research within the mission space of other SC programs.
- Research and/or technology R&D funded by other NP sub programs or any research scope that is duplicative of active SC awards
  - Isotope production.

#### Multi Institutional Proposals and Sub-awards:

- Proposals may be submitted by either a single institution or a multi-institutional consortium.
- All multi-institutional proposals must be submitted as consortium proposals (prime applicant and proposed subawards) via the lead institution.
- Multi-institutional consortium proposals must include the complete budgets and tasks for each institution involved as well as letters of institutional commitment. The research plan and its associated budget(s) should leave no confusion about which institution will do which parts of the research. The lead institution's budget must include all subaward budgets, including any DOE National Laboratory subawards.

Partnerships or coordinated activities with researchers funded from other sources, including other SC programs or other Federal agencies, are encouraged. The scope of the proposed NP work must be clarified for such coordination or partnership.

#### **Open Science**

SC is dedicated to promoting the values of openness in Federally-supported scientific research, including, but not limited to, ensuring that research may be reproduced and that the results of Federally-supported research are made available to other researchers. These objectives may be met through any number of mechanisms including, but not limited to, data access plans, data sharing agreements, the use of archives and repositories, and the use of various licensing schemes. The use of the phrase "open-source" does not refer to any particular licensing arrangement, but is to be understood as encompassing any arrangement that furthers the objective of openness.

#### **Section II – AWARD INFORMATION**

#### A. TYPE OF AWARD INSTRUMENT

DOE anticipates awarding laboratory work authorizations under this DOE National Laboratory Program Announcement.

Any awards made under this Announcement will be subject to the provisions of the contract between DOE and the awardee National Laboratory.

#### B. ESTIMATED FUNDING

It is anticipated that approximately \$6,800,000 may be available over the entire period for all awards made under this Announcement, subject to availability of funds. Within this amount, up to \$6,800,000 may be available in FY 2019.

The number, duration and size of awards will depend on the number of selected awards and available funds in FY2019. The number and amounts of awards will depend on the number and quality of proposals received in each Research Opportunity track.

DOE is under no obligation to pay for any costs associated with preparation or submission of proposals. DOE reserves the right to fund, in whole or in part, any, all, or none of the proposals submitted in response to this Announcement.

#### C. MAXIMUM AND MINIMUM AWARD SIZE

The award size will depend on the number of meritorious proposals and the availability of appropriated funds.

#### Ceiling

Total award values (for all years of the request, and including all subawards) will not exceed:

Research Opportunities I-III: \$1,000,000 per award.

Research Opportunity IV: \$ 200,000 per award for Postdoctoral or Intern support Research Opportunity IV: \$ 150,000 per award for Graduate Student support. \$ 50,000 per award for major conference meetings.

Research Opportunity V: \$ 25,000 per award for workshop meetings. Research Opportunity V: \$ 10,000 per award for PI exchange meetings.

#### Floor

Total award values (for all years of the request, and including all subawards) will not be less than:

Research Opportunities I-IV: \$ 50,000 per award. Research Opportunity V: \$ 5,000 per award.

#### D. EXPECTED NUMBER OF AWARDS

The exact number of awards will depend on the number of meritorious proposals, the results of the merit review, the program policy factors, and the availability of appropriated funds.

#### E. ANTICIPATED AWARD SIZE

The award size will depend on the number of meritorious proposals, the results of the merit review, the program policy factors, and the availability of appropriated funds.

#### F. PERIOD OF PERFORMANCE

The period of performance will depend on the number of meritorious proposals, the results of the merit review, the program policy factors, and the availability of appropriated funds.

Research Grant Awards are expected to be made for a period of one to three years as befitting the project.

The period of performance limitations by Research Opportunities:

Research Opportunities I-IV: Up to 3 years. Research Opportunity V: Up to 1 year.

Continuation funding (funding for the second and subsequent budget periods) is contingent on: (1) availability of funds appropriated by Congress and future year budget authority; (2) progress towards meeting the objectives of the approved proposal; (3) submission of required reports; and (4) compliance with the terms and conditions of the award.

#### G. TYPE OF PROPOSAL

DOE will accept new DOE National Laboratory Proposals under this DOE National Laboratory Announcement. Please only submit a PAMS lab technical proposal in response to this Announcement; do not submit a DOE Field Work Proposal (FWP) at this time. SC will request FWPs later from those selected for funding consideration under this Announcement.

#### **Section III – ELIGIBILITY INFORMATION**

#### A. ELIGIBLE APPLICANTS AND TOPICS

This is a DOE National Laboratory-only Announcement. FFRDCs from other Federal agencies are not eligible to submit in response to this Program Announcement.

#### **B. COST SHARING**

Cost sharing is not required.

#### C. ELIGIBLE INDIVIDUALS

Eligible individuals with the skills, knowledge, and resources necessary to carry out the proposed research as a Principal Investigator (PI) are invited to work with their organizations to develop a proposal. Individuals from underrepresented groups as well as individuals with disabilities are always encouraged to apply.

#### D. LIMITATIONS ON SUBMISSIONS

Applicant institutions are limited to 1 proposal per lead PI. Each PI may be the lead PI of at most one proposal.

There is no limitation on the total number of applications that an institution may submit. DOE will consider the latest received submissions to be the institution's intended submissions.

 Proposals in excess of the limited number of submissions may be declined without review.

#### Section IV – PROPOSAL AND SUBMISSION INFORMATION

#### A. ADDRESS TO REQUEST PROPOSAL PACKAGE

PROJECT NARRATIVE (NO MORE THAN 25 PAGES LONG)

The project narrative **must not exceed 25 pages** of technical information, including charts, graphs, maps, photographs, and other pictorial presentations, when printed using standard 8.5" by 11" paper with 1 inch margins (top, bottom, left, and right). The font must not be smaller than 11 point. Merit reviewers will only consider the number of pages specified in the first sentence of this paragraph. This page limit does not apply to the Cover Page, Budget Page(s), Budget Justification, biographical material, publications and references, and appendices, each of which may have its own page limit.

Do not include any Internet addresses (URLs) that provide supplementary or additional information that constitutes a part of the proposal. Merit reviewers are not required to access Internet sites; however, Internet publications in a list of references will be treated identically to print publications. See Part VIII.D for instructions on how to mark proprietary proposal information. To attach a Project Narrative, click "Add Attachment."

The Project Narrative comprises the research plan for the project. It should contain enough background material in the Introduction, including review of the relevant literature, to demonstrate sufficient knowledge of the state of the science. The narrative should contain appropriate scientific technical information to enable reviewers to assess the merits according to the review criteria provided in Section V.

Suggested sections include:

**Project Objectives**: This section should identify the Topic/subtopic(s) being addressed and state clearly the specific objectives of the proposed work along with its intended impact on NP and QIS.

**Background/Introduction**: Explanation of the importance and relevance of the proposed interdisciplinary work and review of the relevant literature including contributions of the applicant's team are appropriate for this section. The need and potential for the proposed NP-QIS consortia should be emphasized.

**Proposed Research and Methods**: This section should describe the scientific and technical challenges, unique approach(es), and anticipated technical solutions in the topical area that will be addressed. Innovation and exploratory parts of the research should be explained and comparison with other ongoing research efforts provided. Sufficient technical details should be provided for each sub task and deliverable to allow reviewers to assess the proposed work.

**Timetable of Activities**: This section should provide a table outlining, year-by-year, all the important activities or phases of the project, including any activities planned beyond the project period. Responsibilities and deliverables of each institution and investigator must be noted for multi institutional consortium proposals and multi-investigator proposals. Successful applicants must use this project timetable to report progress.

**Project Team and Interdisciplinary Expertise**: Multi institutional consortium proposals and single institution multi-investigator proposals must make a compelling case that the appropriate interdisciplinary expertise is available within the team and justify the need for each investigator. The interdisciplinary expertise must be established even for single investigator proposals.

**Institutional Commitment**: Applicants are strongly encouraged provide evidence of their commitment to the proposed activity. This commitment may take the form of uncompensated effort; the provision of surplus materials, supplies, or equipment; the provision of access to facilities at no or reduced cost; voluntary cost sharing; mentoring, training, or coaching of personnel; the provision of release time for teaching faculty; the provision of scholarship support for students; or other methods of involving the applicant in the proposed activity.

Institutional commitment is **not** a form of cost-sharing: It is intended to ensure that the applicant institution is leveraging existing resources and capabilities to further the public benefit of groundbreaking scientific discovery.

#### Additional Guidance for the Research Opportunities I-IV

In addition, the biographical sketch must include information to permit DOE to identify individuals who are conflicted with or potentially biased (favorably or unfavorably) against the investigator. Include a section entitled "Identification of Potential Conflicts of Interest or Bias in Selection of Reviewers" that will not count in a page limit: Provide the following information in this section:

• Collaborators and Co-editors: List in alphabetical order all persons, including their current organizational affiliation, who are, or who have been, collaborators or co-authors with you on a research project, book or book article, report, abstract, or paper during the 48 months preceding the submission of this proprosal. For publications or collaborations with more than 10 authors or participants, only list those individuals in the core group with whom the Principal Investigator interacted on a regular basis while the research was being done. Also, list any individuals who are currently, or have been, co-editors with you on a special issue of

- a journal, compendium, or conference proceedings during the 24 months preceding the submission of this proposal. If there are no collaborators or co-editors to report, state "None."
- **Graduate and Postdoctoral Advisors and Advisees**: List the names and current organizational affiliations of your graduate advisor(s) and principal postdoctoral sponsor(s). Also, list the names and current organizational affiliations of your graduate students and postdoctoral associates.

**Personally Identifiable Information**: Do not include sensitive and protected personally identifiable information including social security numbers, birthdates, citizenship, marital status, or home addresses. Do not include information that a merit reviewer should not make use of.

This appendix will not count in the project narrative page limitation.

#### APPENDIX 2: CURRENT AND PENDING SUPPORT

#### APPENDIX 6: DATA MANAGEMENT PLAN

Provide a Data Management Plan (DMP) that addresses the following requirements:

- 1. DMPs should describe whether and how data generated in the course of the proposed research will be shared and preserved. If the plan is not to share and/or preserve certain data, then the plan must explain the basis of the decision (for example, cost/benefit considerations, other parameters of feasibility, scientific appropriateness, or limitations discussed in #4). #### 3. Detailed Instructions for the Budget

Budgets are required for the entire project period. A budget form should be completed for each budget period of the award, and a cumulative budget form for the entire project period will be populated by PAMS. A detailed budget justification narrative should be included after the budget pages. The justification should cover labor, domestic travel, equipment, materials and supplies, and anything else that will be covered with project funds.

To edit a section on the budget, click the edit icon ( ) for each section on the page. Remember to save all budget periods before moving on to the next section. - What is the past performance and potential of the Principal Investigator (PI)?
- How well qualified is the research team to carry out the proposed research?
- Are the research environment and facilities adequate for performing the research?
- Does the proposed work take advantage of unique facilities and capabilities?
- Does the team (or individual PI) have the necessary expertise in NP and QIS to carry out the proposed research?
- Does any proposed institutional commitment increase the likelihood of groundbreaking scientific discover?

#### REASONABLNESS AND APPROPRIATENESS OF THE PROPOSED BUDGET

- Are the proposed budget and staffing levels adequate to carry out the proposed research?
- Is the budget reasonable and appropriate for the scope?
- Have applicants appropriately estimated the costs, schedules, and other factors relevant for successful deliverables?
- Have applications described the risks and metrics appropriately?
